See following Tech Data pages for individual warranty information of specific hardware items or accessories. The warranty is to original consumer purchasing the product free of defects in materials, manufacture, or workmanship. The product warranty does not apply if product is damaged by abuse, misuse, or accident. Should the product be otherwise than warranted during this period, EXPI-DOOR Systems Inc. shall repair or replace the product found to be defective. Replace shall mean providing defective material free of charge or an equivalent amount of new product in exchange for product found to be defective. All Labor or other costs of repair or replacement are excluded.

Returned product will not be accepted unless an RMA (return Material authorization) is provided by EXPI-DOOR System Inc. customer service representative. No materials held over 30 days from delivery can be returned. To receive prompt and proper credit please refer to invoice and purchase order number with date product was received. All items being returned must be in restockable condition. Restocking fees on returned stock product may apply, special order products shall not, cannot be returned.

## **FREIGHT CLAIMS**

1. Freight claims are **not** considered a part of the warranty process.
  - a. Once product leaves the EXPI-DOOR® Systems Inc. dock, it becomes the freight carrier and receivers responsibility.
  - b. When the receiver signs the delivery receipt from the driver, the material then becomes the receiver's responsibility.
2. Examine freight before driver leaves and note ANY damage on delivery receipt no matter how small.
  - a. If there is damage noted, please contact EXPI-DOOR® Systems Inc. right away at 920-393-4028. We will work at getting you what you need ASAP.
  - b. If damage is extensive, please refuse freight due to damage contact EXPI-DOOR® Systems Inc. ASAP and replacements will be worked on ASAP.
3. If damages or shortages are noticed any point after the driver departs from the delivery point, the receiver is then solely responsible for replacements.
  - a. If you notice damage after the diver has left you have five days to reach out to EXPI-DOOR® Systems Inc. with pictures to get a hidden freight claim filed.
  - b. The receiver will be responsible for the cost of the replacement, but EXPI-DOOR® Systems Inc. will file a hidden freight claim and will credit that chargeable PO if the carrier honors the hidden freight claim.

# SERIES DB SPECIFICATIONS

## A. INTRODUCTION:

- A.1.0 The following information pertains to EXPI-DOOR's current Series DB door offering. We will discuss the specifics of preassembled door systems, as well as knock-down door systems. We will also discuss all hardware components of each system, as well as the creation or grouping of these items.
- A.1.01 All door systems provided by EXPI-DOOR are considered as "medium to heavy-duty commercial" type.
- A.1.02 Our Series DB offering was created specifically to offer a cost-effective product for light- to medium-duty environments. It should also be noted that this product line is similar, but superior to our competitor's standard offering of door systems.

## B. SUBMITTALS:

- B.1.0 For standard orders, where no special, non-stock conditions exist, our clients are encouraged to use the product data included here-in and in the following pages. This includes door and frame gauges, hardware grades, designs and finishes, and any other associated components that apply to the final design and assembly of the product.
- B.1.01 For non-standard orders, and where EXPI-DOOR provided a "specialized product" type quote for non-stock materials, it is required that our client contact the person responsible for that quotation and request a detailed submittal. This will be done at no cost to our client.
- B1.02 Submittals must be approved by a signature from the architect or end-user prior to ordering from EXPI-DOOR. EXPI-DOOR reserves the right to hold any order until the submittal is positively approved by the appropriate entity.

## C. QUALITY ASSURANCE

- C.1.01 EXPI-DOOR products pass through a minimum of three stations. First is a preparation and fabrication station. The second is the assembly station. The third is the final examination and packaging station. After installation of hardware items, each is tested to ensure proper alignment and function. Upon completion, product is inspected by a third-party for final quality appearance.

  - 1. Flush, welded-in top channel (rail) shall be 14 gauge.
  - 2. Inverted, welded-in bottom channel (rail) shall be 14 gauge.
  - 3. Closer reinforcement "tube" of 14 gauge shall be inserted prior to insertion of core and prior to final joining of face sheets.

- B. Frame finishes shall consist of baked-on tinted primer per ANSI A250.10 in either white or bronze. Primer shall also consist of zinc-based, rust-inhibitive properties. This finish can be painted over in the field by others.

- C. Reinforcements and preparations.
  1. Strike prep shall be 4 7/8" high, ASA. Strike prep shall be filled, or covered with a filler plate in the rim panic (exit) device applications.
  2. Hinge preparations shall be of 7 gauge steel. Frames shall consist of 1 ½ pair, fully-mortised, 4.5" high, set-up for standard-weight hinges, with optional heavy-weight hinge set-up.
- D. Attachment of threshold: EXPI-DOOR will attach the standard threshold to the frames to create a fully preassembled unit. This is accomplished by inserting (2) self-drilling, self-tapping TEK hex head screws into the reverse of each jamb, and into the fluted channels on the under-side of the threshold. All "special" thresholds do not have this capability and will be shipped loose assembly.
- E. Corner connections.
  1. **\*\*Standard\*\***: Mitered each end of header and top of each jamb. Slot-and-tab connection then back-welded by EXPI-DOOR before final assembly. Covers fire-rated applications.

  2. Expandable concrete sleeve anchor, zinc plated – prime painted Phillips head, 3/8" diameter, 5" length, #4 Phillips driver.
  3. Wood screw, ¼" diameter, 4" length, zinc plated, #4 Phillips Driver.
  4. Threaded-rod, 3/8" diameter, 4" length, zinc plated – prime painted Phillips head, w/ star washer and lock-nut, #4 Phillips driver.
  5. Fully-threaded hanger bolt x 4-1/2" length, zinc plated – prime painted Phillips head, #4 Phillips Driver (for existing wood stud applications).
